IV. Schedules 2018-19

A. Winter

1. Wrestling

The coaches reviewed the possible schedules for 2018-19 season and decided on a double dual format with dual only rival competition. The league competition would begin in January. The double dual will avoid starting league play in December and then having a 2-week break and it would also consolidate the current schedule from 5 weeks to 3 weeks.

2. Basketball

The President of the league, Ed Santopadre, expressed some concern to Joan regarding the way the discussion and voting took place for moving basketball to T/Th and W/F for next season. The item will be on the BOM agenda for the April meeting. With this in mind, both schedules will need to be available for voting purposes for the April meeting. Eddie will look to make some adjustments to the basketball schedules based on the new wrestling schedule.

3. Soccer

No changes were made from the tentative January 18th schedules.

C. Spring

1. Badminton—

Coaches agreed that for the 2-day league tournament singles would play on one day and doubles the other day. The competition start time would be 4:00pm both days

2. Baseball—

a. Schedule with corrections will have baseball beginning Wednesday March 13 and leave room at the end for any needed makeup games.

b. There was also a discussion regarding a series type schedule for the future. A series schedule would have the same two teams playing 3 games in a row such as M, W, and F. The series idea will be a discussion item at the next BOM.
