# **MEL League Business**

- MEL Calendar was presented and discussed. Additions were solicited. General impression was positive.
- Davis football joining the MEL was discussed. Schools mentioned they already had contracts to fill the bye week in 25-26. The section is looking at the conference model possibly beginning in the next 1-2 years. Vote was 4-2(1 absentee) in favor of not admitting Davis Football.
- Schedules for next season were presented. Some schools will make corrections and add to the folder. Spring sports wanted to wait until 25-26 Sports Schedule is released from the section with exact dates.
- All League voting was discussed by Fall sports. Football did not respond. Fall:

**Flag Football**- All League meeting ok. After 1st year Coaches want to review bylaws. Making schedule changes

# **Spring:**

AD's proposed to bump schedules to the last BOM for approval due to SJS Sports calendar not being adjusted

T&F- Nothing reported

Athletic Directors would like to rotate meetings (AC and BOM) between schools.

Athletic Directors would prefer no Virtual /Zoom meetings. They felt with the rotation the travel burden is felt by all.

Wrestling: The sport growing for the girls. No bylaw dictates the number of athletes that constitute a team. This needs to be decided. Group votes to do a Girls banner. The group felt that with a girls league beginning the practice of girls filling in and wrestling for the boys should not be allowed.

Bylaw update wrestling: LEAGUE TOURNAMENTS:

**6.13-1** J.V. and Girls championships will be held in conjunction with the league championship. Any J.V. or Girl, not involved in the varsity championship may participate. A Novice scrimmage will be held the Wednesday before Thanksgiving, hosted by the previous year league tournament host school. Eligible wrestlers shall not have medaled in a varsity tournament.

**6.13-2** A League tournament is to be held the week following the section team tournament.

**6.13-1** J.V. championships will be held in conjunction to the league championships. Any J.V. not involved in the varsity championship may participate. J.V. and Girls championships will be held in conjunction with the league championship. Any J.V. or Girl, not involved in the varsity championship may participate.

• Volleyball and Flag Football bylaws need to be approved by the BOM. Discussion was held around having AD's make suggestions for changes. Some AD's felt this was too much work. The group decided that it should be less work with no new sports being added. AD's will make recommendations, BOM will vote and the Commissioner will get changes posted.

### Basketball foundation games
